RELEASE and WAIVER of LIABILITY for NEGLIGENCE EXECUTED on BEHALF of a MINOR by MINOR'S PARENT or LEGAL GUARDIAN, ASSUMPTION of RISK, INDEMNITY and SAVE HARMLESS AGREEMENT ("AGREEMENT")

IN CONSIDERATION of _____ the minor being permitted to participate in any way in the Superdome Sports activity, I the parent and natural guardian of said minor, or myself, or personal representatives, assigns, heirs, and next of kin of said minor...

1. ACKNOWLEDGE, agree, and represent that I understand the nature of such activities and that I am of the opinion that said minor is qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe that such minor's health and physical condition should change so that it would be unsafe for such minor to continue to participate in such activity, I will immediately discontinue the minor's future or further participation in such activity.

2. I FULLY UNDERSTAND THAT: (a) such minor's participation in the aforesaid activities involve risk and danger of serious bodily injury, including permanent disability, paralysis, and death ("risks"); (b) these risks and dangers may be caused by said minor's actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of Unlimited Sports, LLC., and Superdome Sports, LLC.; (c) there may be other risks and social economic losses either known or not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and responsibilities for losses, costs and damages such minor may incur as a result of the minor's participation in the activity.
